2	Within three days of the announcement of election schedule members/firms desiring to change their representative shall intimate changes regarding names of representative to the secretary general along with necessary proof of eligibility.	18 July, 2026 (Saturday)
3	Within seven days of announcement of election schedule, Secretary General of Association display the provisional list of all members eligible to vote along with their national tax number, sales-tax registration number, if applicable, the name and national identity card number of their representative at notice board of the head office, regional offices and website of the Association.	25 July, 2026 (Saturday)
4	Within seven days of issuance of the voters list, Objections to entries of voters list from member in writing to the secretary general.	01 August, 2026 (Saturday)
5	Within five days from receipt of objections, the secretary general intimate objections or changes, if any.	7 August, 2026 (Friday)
6	Any person/member aggrieved by decision of the secretary general may, within three days of receipt of the decision, make a representative to Election Commission which shall decide the representation within three days.	10 August, 2026 (Monday)
7	Any person/member aggrieved by decision of the Election Commission may file appeal to DGTO within three days of decision of Election Commission.	12 August, 2026 (Wednesday)
8	DGTO shall decide the appeal within 10 days and his decision in this regard shall be final.	19 August, 2026 (Wednesday)
9	If no appeal filed to DGTO the final list of voters shall be displayed on notice board of head office, regional office and at website of Association within fifteen days of the decision of Election Commission	22 August, 2026 (Saturday)
10	Issuance nomination papers to the eligible voters by secretary general & notice to the member inviting the election on vacant seats of Executive Committee of APMIA.	24 August, 2026 (Monday)
11	Within four days of display of final list of voters, who is eligible to contest elections for the vacant post, shall send his nomination <u>duly proposed and seconded by a registered voter</u> and signed by the candidate to the secretary general.	29 August, 2026 (Saturday)
12	Within twenty four hours of receipt of nomination papers, a copy of final list of voters shall be provided to each contesting candidate.	31 August, 2026 (Monday)
13	Scrutiny of nomination papers by Election Commission and display of list of candidates within twenty four hours of the last date of receipt of nomination papers.	1 September, 2026 (Tuesday)
14	The objections, if any, to the nomination of the candidate to the election commission may be filed within twenty four hours of issuance of the candidates.	2 September, 2026 (Wednesday)
15	Decision on objections of the candidates by the election commission within two days	4 September, 2026 (Friday)

16	Appeal to the DGTO by any aggrieved candidates against the decision of Election Commission (DGTO shall give decision within seven days and his decision in this regard shall be final)	7 September, 2026 (Monday)
17	Submission of Withdrawal of Executive Committee Nominations to Election Commission	8 September, 2026 (Tuesday)
18	Final decision of the Regulator/DGTO on any appeal against the candidate list. The final list of candidates shall be issued after the decision of the Regulator.	14 September, 2026 (Monday)
19	Issuance of the Final List of Candidates for contesting Election for the Executive Committee	15 September, 2026 (Tuesday)
20	Poling for the election of members of Executive Committee (If the number of candidates exceeds than the vacant seats, if not, the final list of elected Executive Committee shall be issued)	17 September, 2026 (Thursday)
21	The elected Executive Committee member to obtain nomination papers for the election of office bearers from Secretary General (Within two days of poling)	18 September, 2026 (Friday)
22	Submission of Nomination Papers for the Office Bearers to the Election, duly Proposed and Seconded by an elected executive committee members and signed by the candidate,	21 September, 2026 (Monday)
23	Scrutiny of nomination papers of the candidates for election of office bearers by the Election Commission and its display within twenty four hours of the last date of receipt of nomination papers.	22 September, 2026 (Tuesday)
24	Submission of Withdrawal of Office Bearers Nominations to Election Commission	23 September, 2026 (Wednesday)
25	Poling for election of office bearers, within two days of display of final list of candidates.	24 September, 2026 (Thursday)
26	Final announcements of election results of members of Executive Committee and Office Bearers in the Annual General Meeting (AGM) (Within fifteen days from the date of poling of office bearer's election).	29 September, 2026 (Tuesday)
